**Job Goal:** To oversee the day-to-day management of the district's operations, ensuring all aspects of the district run smoothly and efficiently by developing and implementing strategic operational plans, managing department budgets, supervising staff and making operational decisions to meet the district's goals.

Supervises: All Custodial, Maintenance, Grounds, Food Service, Transportation, and Technology staff

### Performance Responsibilities:

- Oversees the operation and maintenance of all school facilities and supervises custodial, maintenance
  and grounds services, ensures that all local, state/federal standards for the health and safety of
  students and staff are maintained and that required reports are maintained.
- Oversight of the development and implementation of a multi-year (3-5 years) comprehensive maintenance plan and the district's long-range facilities master plan.
- Is responsible for the efficient operation of the district's food services program; ensures that procedures
  are in accordance with law and regulations; and supervises food service personnel in coordination with
  the district's food service supervisor.
- Is responsible for the safe, efficient operation of the student transportation program; ensures proper maintenance of district-owned buses in coordination with the district transportation supervisor.
- Ensures technology infrastructure including security cameras and communication systems are operational in coordination with the district technology coordinator.
- Manages the implementation and development of facility needs and oversees all construction programs. Helps develop educational standards for sites, buildings and equipment; prepares cost data; and cooperates with architect and construction supervisor during construction programs.
- Acts as the agent of the Board in site acquisitions and sale/lease of property. Oversees scheduling the
  use of school buildings and grounds by authorized groups in accordance with board policies.
- Assists in recruiting, screening, hiring, assigning, supervising, and evaluating personnel for positions in the offices under his/her jurisdiction.
