## Harrah's Atlantic City Conference Center

### March 22, 23, 24 & 25

#### **NJSBGA Regular Member (Non-Vendor)**

**\$350.00**

This line is for regular members that are current with their chapter dues that are **not** members of Atlantic, Burlington, Mercer, Camden or Monmouth/Ocean Chapters. A purchase order or full payment will be required prior to the event. Membership will be confirmed upon registration. Those registering that are not confirmed members in good standing will be notified and their registration will be adjusted accordingly. **All** meal tickets are included for the member. The member will be responsible for additional meal tickets for guests/spouses. Each attending individual must be registered individually. **This line is not for vendors or Associate Members and does not include housing.**

#### **NJSBGA Regular Member (Monmouth, Mercer, Atlantic, Camden & Burlington Chapters) Non-Vendor.**

**Prepaid**

**This line is only for regular members of the Atlantic, Burlington, Camden, Mercer or Monmouth/Ocean Chapters** that are in good standing and have met the minimum requirements for attendance to be eligible for payment for the conference. All registrants that select this option that are not members in good standing will have their registration and fee adjusted and will be notified. **All** meal tickets are included for the member. The member will be responsible for additional meal tickets for guests/spouses. Members of the above chapters must be in good standing. **This line is not for vendors or Associate Members and does not include housing.**

#### **Non-Member Employee of Member NJSBGA District**

**\$525.00**

This line is for nonmembers of the NJSBGA that are employed in member districts (Districts where one or more employees are members of the NJSBGA) Payment in full or a PO will be required for confirmation prior to the event. **All** meal tickets are included. The participant will be responsible for additional meal tickets for guests/spouses. Tickets are available later in the registration process. **This line is not for vendors or Associate Members and does not include housing.**

#### **Non-Member School Employee (No NJSBGA Affiliation and Not a Vendor)**

**\$625.00**

This line is for those that wish to attend that are employed by schools or colleges that are not members of the NJSBGA or have other employees that are members of the NJSBGA. Registrant must confirm employment in a school or college. **All** meal tickets are included. The participant will be responsible for additional meal tickets for guests/spouses. Tickets are available later in the registration process. Payment in full or PO must be received prior to the event. Confirmation will be sent upon receipt. **This line is not for vendors or Associate Members and does not include housing.**

**NJSBGA Associate Member-Single Regular Vendor Booth** **\$1800.00**

This line is for Associate Members of the NJSBGA in **good standing**. Each booth will be allowed 4 total individuals. There will be a fee for additional persons of \$250 each payable later in the registration process. All applications for booth space will remain pending until payment is received. Payment must be received within two weeks of the registration or the registration will be cancelled. Includes Lunch 3/23 and Breakfast/Lunch 3/24

**NJSBGA Associate Member-Double Regular Vendor Booth** **\$2900.00**

This line is for Associate Members of the NJSBGA in good standing. Each booth will be allowed 8 total individuals. There will be a fee for additional persons of \$250 each payable later in the registration process. All applications for booth space will remain pending until payment is received. Payment must be received within two weeks of the registration or the registration will be cancelled. There will be a maximum of two booths per vendor. Vendors that register under different company names will not be permitted to have the booths together. Includes Lunch 3/23 and Breakfast/Lunch 3/24.

**Non-Associate Member-Single Regular Vendor Booth** **\$2200.00**

This line is for Non-Associate Members of the NJSBGA. Each booth will be allowed 4 total individuals. There will be a fee for additional persons of \$250 each payable later in the registration process. All applications for booth space will remain pending until payment is received. There will be a maximum of two booths per vendor. Vendors that register under different company names will not be permitted to have the booths together. Payment must be received within two weeks of the registration or the registration will be cancelled. Includes Lunch 3/23 and Breakfast/Lunch 3/24

**Non-Associate Member-Double Regular Vendor Booths** **\$3600.00**

This line is for Non-Associate Members of the NJSBGA. Each booth will be allowed up to 8 total individuals. There will be a fee for additional persons of \$250 each payable later in the registration process. All applications for booth space will remain pending until payment is received. There will be a maximum of two booths per vendor. Vendors that register under different company names will not be permitted to have the booths together. Payment must be received within two weeks of the registration or the registration will be cancelled. Includes Lunch 3/23 and Breakfast/Lunch 3/24.

**NJSBGA Associate Member-Single Premium Vendor Booth** **\$2700.00**

This line is for Associate Members whose dues are current requesting a single premium booth. You are entitled to up to four badges. Additional badges will be available later in the process for \$250 each. There will be a maximum of two booths per vendor. Vendors that register under different company names will not be permitted to have the booths together. Payment must be received within two weeks of registration or the registration will be cancelled. Includes Lunch 3/23 and Breakfast/Lunch 3/24

**NJSBGA Associate Member Double Premium Vendor Booth** **\$3600.00**

This line is for Associate Members whose dues are current requesting a double premium booth. You are entitled to up to eight badges. Additional badges will be available later in the process for \$250 each. There will be a maximum of two booths per vendor. Vendors that register under different company names will not be permitted to have the booths together. Payment must be received within two weeks of registration or the registration will be cancelled. Includes Lunch 3/23 and Breakfast/Lunch 3/24

**Non-Associate Member-Single Premium Vendor Booth** **\$3300.00**

This line is for Non-Associate Members (Vendors) requesting a single premium booth. You are entitled to up to four badges. Additional badges will be available later in the process for \$250 each. There will be a maximum of two booths per vendor. Vendors that register under different company names will not be permitted to have the booths together. Payment must be received within two weeks of registration or the registration will be cancelled. Includes Lunch 3/23 and Breakfast/Lunch 3/24

**Non-Associate Member-Double Premium Vendor Booth** **\$4000.00**

This line is for Non-Associate Members (Vendors) requesting a double premium booth. You are entitled to up to eight badges. Additional badges will be available later in the process for \$250 each. There will be a maximum of two booths per vendor. Vendors that register under different company names will not be permitted to have the booths together. Payment must be received within two weeks of registration or the registration will be cancelled Includes Lunch 3/23 and Breakfast/Lunch 3/24

**Spouse Badges****\$200.00**

Spouse badges will be available for payment and pickup at the show. Spouse badges include all meals and the Banquet Buffet 3/25. They do not include any of the available CEU classes.
